**BEHAVIOR POLICY**

Cornerstone Christian Academy strives to offer an exceptional educational program for children educated at home. As a part of our quality program, the following policy outlines the behavior expectations of the students while on campus. Please review this policy carefully with your child, sign where indicated, and return to the school.

The children attending Cornerstone Christian Academy will be expected to adhere to the following behavior guidelines:

**1 - Honor God in all aspects of behavior**

- Use language that is honoring to God. No obscene language or inappropriate dialog will be tolerated.
- Dress shall be conservative and respectful in accordance with the school dress code.

**2 - Respect all adults and people who are in authority**

- Children shall be required to listen to teachers and follow their guidelines and directives without interruption.
- Students are expected to complete tasks and participate as assigned.
- Respect must be given to teachers at all times. No arguing with teachers is allowed.

**3 - Respect fellow students**

- Children will be expected to treat other students with kindness and respect.
- Students are required to allow fellow classmates equal time for sharing ideas.
- Positive comments toward fellow students' ideas will be encouraged. Negative or demeaning commentary will not be allowed.
- Language should be kind and encouraging.
- No inappropriate touching.

**4 - Accept responsibility for one's belongings and for the school facility**

- Students are expected to care for their own belongings in a responsible manner.
- Students are expected to exhibit respect and care for the school facilities.
- Children are to clean-up after themselves following class activities and lunch period.

**5 - Exhibit good manners**

- Children are expected to use respectful titles, such as Mr. and Mrs., when addressing teachers or adults.
- Students are expected to use polite language, i.e., please, thank you, etc.
- To help prevent illness, children are expected to wash hands before eating and after using the restroom.

If a student fails to adhere to the above listed behavior expectations, the following policy has been established. This policy is designed to address the issue at hand and assist the parent and child in dealing with the behavioral issue. The school's goal is to help the child become a positive contributor to the school environment. The teacher and administrator will determine when a particular issue requires attention.

**First Offense** – Student will be addressed regarding his/her failure to comply with the school behavior guidelines. The teacher may elect to remove the student from the class for a brief period to reflect on his/her behavior.

The teacher and administrator may choose to use this consequence more than one time before proceeding to the next stage of disciplinary action.

**Second Offense** – Parents will be notified of the child's behavior, and the issue will be discussed with the teacher and administrator. Ideas regarding how to correct the problem will be addressed and implemented.

**Third Offense** – Parents will be notified and the child will be removed from one full day of classes. The parents will not be refunded tuition for that day of school.

**Fourth Offense** – The administrator and teacher will discuss the appropriate action to be taken. The objective is to help the child and parent resolve the behavioral issue. As a last resort, the child may be asked to leave Cornerstone Christian Academy indefinitely. Should the administrator and teacher elect this course of action, the parents will not be refunded any of the remaining tuition for that month.
